1. Introduction

- 1.1. These Terms and Conditions ("Terms") govern the STARTRADER "Mission from the Stars" Promotion ("Promotion").
- 1.2. By participating in this Promotion, the participant agrees to be bound by these Terms.
- 1.3. STARTRADER reserves the right to modify, suspend, or terminate the Promotion at any time, at its sole discretion.

2. Program Period

- 2.1. The Promotion will run for a total of seven (7) weeks, starting from October 20th, 2025 and ending on December 7th, 2025, based on server time.
- 2.2. Each week, one character will be unlocked with a unique mission requirement.
- 2.3. Participants may join the Promotion at any point during the campaign but will only be eligible for the current and subsequent week's missions unless recovery conditions are met (see Clause 6).

3. Applicable regions

This activity is applicable to global clients.

4. Applied Product

All trading products are eligible for this promotion.

5. Eligibility

- 5.1. The Promotion is open to all clients of STARTRADER, excluding those residing in restricted jurisdictions.
- 5.2. To participate, clients must:
 - Make a new deposit of at least \$500 during the Promotion Period;
 - Opt-in to the Promotion through the STARTRADER Client Portal; and
 - Maintain a verified trading account in good standing throughout the Promotion.



5.3. The following account types are excluded from eligibility: Cent accounts, Cryptocurrency accounts, PAMM accounts, and MAM accounts.

6. Weekly Missions & Rewards

- 6.1. Each week, one exclusive IP character will be unlocked. The reward is granted upon successful completion of the corresponding mission.
- 6.2. The mission schedule is as follows:

Week	Character	Mission Requirement
1	Quant Pioneer	Trade 10 standard lots of Forex
2	Crypto Hunter	Trade 3 standard lots of Crypto
3	Gold Defender	Trade 5 standard lots of Gold
4	Neon Navigator	Maintain open positions for at least 5 consecutive days
5	Global Operator	Execute 30 completed trades (any instrument)
6	Green Guardian	Trade at least 1 lot per day for 3 consecutive days
7	🔒 Secret Character	Eligible only if participant: - Has collected all 6 characters from Weeks 1–6 - Has generated at least \$100 in net profit during the Promotion Period

6.3. Reward Structure:

Complete Fewer than 6 Missions:

- Participants will receive one (1) random character box per mission completed (maximum of 5).
- Characters received will be randomly selected from the ones associated with completed missions.

Complete All 6 Character Missions (Weeks 1–6):

- Participants will receive a complete box set (6 individual boxes, one for each character).

Participants who successfully complete all 7 missions—by collecting all 6 characters and meeting the net profit condition of at least \$100—will receive:

- An exclusive STARTRADER display stand box to showcase their full collection
- A Completion Certificate issued by STARTRADER



- The Secret Character is a limited-edition collectible with only 50 units available globally.
- 6.4. If more than 50 participants meet the eligibility criteria by the end of Week 7, STARTRADER will conduct a fair random draw among qualified participants to select the 50 winners.
- 6.5. Each eligible participant may only win one (1) Secret Character.
- 6.6. All participants who complete all 7 missions—whether selected or not for the Secret Character—will still receive the completion certificate and display stand box.
- 6.7. All prizes, including character boxes, complete box sets, display stand boxes, and the Secret Character, are subject to limited availability. Rewards will be distributed on a first-come, first-served basis while stocks last.

7. Reward Distribution

- 7.1. Rewards may be delivered in physical collectible form, digital format (e.g., badge or certificate), or as an equivalent bonus item based on participant region and availability.
- 7.2. Shipping costs (if applicable) will be borne by STARTRADER.
- 7.3. Rewards will be processed and delivered within 60 calendar days after the Promotion ends.

8. Missed Mission Recovery

- 8.1. If a participant fails to complete a mission during any of Weeks 1–6, they may recover the missed character by:
 - Making an additional deposit of at least \$1,000; and
 - Trading at least 15 standard lots during the Promotion Period (before Week 7 ends).
- 8.2. Each participant may recover a maximum of two (2) missed characters through this method.

9. General Terms

- 9.1. Only closed positions will be counted toward mission requirements.
- 9.2. Trades must be executed in accordance with STARTRADER's trading policies.
- 9.3. Internal transfers, balance or cash adjustments, Introducer/Affiliate rebates or commissions of any kind will not be considered new deposits and therefore will not be counted towards this Promotion.
- 9.4. This promotion can be used in conjunction with other promotional privileges.
- 9.5. Clients have the full obligation to keep a sufficient margin level within the promotion period, as STARTRADER may not remind you when your equity/credit is less than or equal to 120%. Withdrawal or bonus cancellation might result in a lower margin for your positions and might cause liquidation due to insufficient



- margin. Clients should carefully consider their risk tolerance level and financial situation prior to making any withdrawal request.
- 9.6. During the promotional period, STARTRADER reserves the right to disqualify participants, revoke eligibility, deduct improperly obtained promotional benefits, or terminate its business relationship with any client found to be in material breach of these Terms and Conditions.

Improper or abusive trading behavior includes, but is not limited to, the following:

- i. Operating multiple accounts from the same IP address with the intent to exploit promotions;
- ii. Engaging in arbitrage trading using multiple accounts, whether within STARTRADER or across different brokers;
- iii. Using strategies such as scalping, high-frequency trading, latency arbitrage, or malicious hedging in a way that disrupts platform integrity;
- iv. Placing abnormally large or disproportionate trades during key trading periods without a sound trading rationale;
- v. Replicating similar trades across accounts to artificially increase exposure;
- vi. Concentrating trading activity on a narrow range of products in a way that creates abnormal risk conditions;
- vii. In bonus-related promotions, allocating more than 70% of trading volume to a single product or maintaining a consistently one-directional trading strategy;
- viii. Any other behavior deemed to be a violation of the STARTRADER Client Agreement, including behavior reasonably defined as default events or suspicious trading activity.

STARTRADER retains discretion in identifying abusive trading activity. However, we are committed to fair and reasonable evaluation and, when feasible, will provide a general explanation if promotional benefits are withheld or accounts are disqualified.

To protect platform integrity and client confidentiality, STARTRADER may not disclose detailed methodologies or internal risk detection systems used in these assessments. In the event of disputes, clients are encouraged to contact STARTRADER support for resolution.

Clients are also expected to engage respectfully in all communications. While STARTRADER respects the right to share opinions and experiences, it reserves the right to respond to defamatory or knowingly false public statements that may cause reputational harm, including by pursuing appropriate legal remedies where necessary.

- 9.7. When a client's balance becomes negative during the promotion, the bonus will be offset against the loss caused by the negative balance. When your negative balance exceeds 1000 USD, STARTRADER reserves the right to refuse the client's request to clear the negative balance.
- 9.8. STARTRADER reserves the right to amend, suspend, or terminate the Promotion at any time, without prior notice and at its sole discretion.
- 9.9. Translations of these Terms and Conditions are provided for convenience only. In the event of any inconsistency or discrepancy, the English version shall take precedence.



10. Disclaimer and Limitation of Liability

- 10.1. STARTRADER does not guarantee the availability of all character models in all regions.
- 10.2. STARTRADER shall not be liable for any technical issues, delays, or failures in reward delivery due to circumstances beyond its control.
- 10.3. Participants are solely responsible for complying with any local laws or tax obligations related to receiving rewards.

11. Risk Warning

The purpose of the bonus is to increase the chance of profits, not to provide a credit loan. In this way, clients should always be aware of the actual margin amount at any time. When the actual available margin in your account is insufficient, you shall add more margin in time to avoid automatic position closure.
